What is a QIN-QIO?

Required by statute, the Quality Innovation Network-Quality Improvement Organization (QIN-QIO) Program is one of the largest federal programs dedicated to improving the effectiveness and quality of health care services delivered to people with Medicare.

The Centers for Medicare & Medicaid Services (CMS) contracts with organizations like **Comagine Health** to carry out the program mission. As the current QIN-QIO contractor for Idaho, Nevada, New Mexico, Oregon, Utah and Washington, Comagine Health assists with:

- Quality improvement and patient safety initiative implementation
- Capacity building through education and training
- Community convening to align and advance common goals

Future of the QIN-QIO Program

CMS updates the QIN-QIO Program each contract cycle to ensure it meets provider and community needs, and moves the dial on quality and safety. CMS has recently announced changes to the program, including the formation of seven QIN-QIO regions, combining setting-specific programs into one cross-setting contract and securing greater alignment with key federal strategies for quality and health equity. Comagine Health will engage our communities to plan, design and implement a transformed QIN-QIO Program, with a focus on:

Focus Areas

- Build the capacity of health care providers across settings to improve quality and safety
- Preventing opioid harms, improving access to behavioral health and substance use disorder treatment
- Improving nursing home care
- Preventing and managing chronic diseases like diabetes, hypertension and chronic kidney disease, and increasing preventive services like immunizations
- Improving care coordination and care transitions to reduce unnecessary hospitalizations, emergency room visits and readmissions
- Convening community organizations and health care providers to address social determinants of health and gaps in health equity
- Innovative and sustainable approaches to better care delivery, quality improvement and patient safety
- Engaging with and developing health care workforce and leadership
- Applying a rural health and health equity lens to QIN-QIO activities, including culturally tailored and responsive interventions and working with culturally-specific and community-based organizations
- Implementation and optimization of new technology to make better use of data in quality improvement and community health initiatives, and leverage technology to expand workforce capacity and coordinate care
